
Review of Twisters



to get work done. This is also what they have done to the U.S. Agency for International Development, which has been responsible for providing development assistance to countries worldwide.



Opinion: Nebraska Farm Real Estate Report

The University of Nebraska Lincoln has done a report of the farm estate and says with how the prices are going into inflation that the price per acre for farming is \$4,015 in 2024. With the inflation the interest rates and low crop prices have forced to tighten the financing or forced to foreclose because they can't make it work out. The net farm income decreased 17% in 2024 to \$7.69 million. Center pivot irrigated ground average 4% lower across the state then last year while irrigated ground average 5% lower across the state. Dryland with no irrigation averaged 2% across the state and dryland ground with irrigation dropped about 3%. Nebraska is facing a decline in crop prices while cattle prices are still high which may or may not stay like that forever because the prices are changing everyday so that means if today is low tomorrow could be up a bunch.

Here is probably the last update about the Powerschool Security breach over Christmas break, which I have covered here and in previous messages. Search "Powerschool SIS Incident" or scan the QR code to see the company's overview of what happened, and details about what you can possibly do if you'd like.



Recently, you may have been contacted by Powerschool via email and been offered a free year of credit monitoring or identity theft protection. Starting now, anyone affected (basically, any parent/student currently or recently enrolled at Litchfield) may use the links on that site, whether you've been contacted by PS or not. There are different protections to redeem depending on whether someone is above or below 18.

Vice President Cole Lewandowski called the regular meeting to order at 7:30 p.m.

Vice President Cole Lewandowski announced and informed the public that a current copy of the Open Meeting Law is posted on the wall of the meeting room and indicated the instructions for those who wish to speak during public forum.

Marie Sweley moved and Katie Slack seconded to approve excused absent Board member Mitch Feldman. Motion carried 5-0.

Alyssa Reynolds moved and April Gross seconded to approve board minutes from last month's meeting. Motion carried 5-0.

Students are required to have a valid DMV-issued permit and a minimum of 10 hours driving practice before participating in this course. Registration will not be accepted without payment of either the down payment or full payment. Registration deadline is two weeks prior to the course start date or until the class is filled, whichever occurs first.

Cancellation/Refund Policy

To receive a refund, written notification must be received more than 5 business days prior to the start of class.

The Nebraska Safety Center reserves the right to cancel class due to low enrollment, inclement weather or other unforeseen circumstances. In such cases, registrants will be given the option to choose a different class (dependent upon availability) or to receive a full refund.

Attendance

Attendance is critical to the student's success. Each class and driving appointment must be attended as scheduled. Outcome is performance-based.

Accommodations

If a student requires accommodations due to an AD. recognized disability, please contact the Nebraska Safety Center prior to registering. The Nebraska Safe Center does not have specialized training to assist persons with vehicle adaptation needs such as peda extensions or hand controls, etc. If your teen has a medical condition or takes medication which affects their ability to operate a motor vehicle, please repor that prior to registering. Medical clearance from a physician may be required to participate in this class

Waivers

If the driver education student is UNDER 18 years of age at the time the course is completed, a waiver for the written and drive tests at the Nebraska DMV will be provided. If the student is 18 or older, a certificate of completion will be provided but the written and driving tests MUST be taken at the DMV Examining Office per state law. Driver's licensing staff, at their discretion, may require a drive test of ANY license applicant. The vehicle must be furnished by the applicant for the drive test at the DMV. The Safety Center will not provide a car for testing at the DMV.
