Marie Sweley moved to participate in the 2022-2023 Consortium with ESU 10 for the ESSA Title Funds and contract for Title 1A services. Second by Jim holm. Motion carried 5-0.

Cole Lewandowski moved to purchase the CKLA reading curriculum to be the implemented for the 2022-2023 school year. The funds will come out of the General Fund and be reimbursed
