President Mitch Feldman announced and informed the public that a current copy of the Open Meetings Law is posted on the wall of the meeting room, and also indicated the instructions for those who wish to speak during the public forum.

The minutes of the last meeting were read. Bill Howard made a motion to approve the minutes from the last meeting. Second by Steve Heapy. Motion carried 5-0.

The treasurer reported a balance of \$897,759.33 in the district treasury. Payroll and claims in the amount of \$209,362.25 were presented for payment. Todd Wardyn made a motion to pay the claims. Second by Bill Howard. Motion carried 5-0.

Matt Drew reported on Students signing up for classes, Preschool update, Music Program, Curriculum for certain classes, ACT online went well and finish up NSCAS testing, Elementary Track Meet, Graduation May 5th, and NETA this week.

In the Superintendent's Report Wade Finley discussed Policy update, ESU Title 1 Cooperative Agreement, Personnel/Staffing 2018-2019, State Evaluation for Lunch Program Summary, ALICAP Safety Inspection, Building and Grounds, Co-op follow-up, and considering classified staff salary raises.

Wade Finley and Matt Drew discussed the points that were noted in our ALICAP Safety inspection and some points of interest that needed attention with the Buildings and Grounds and will be getting bids to redo some concrete going into the main building. Wade will also bring bids for a buzzer system to the May meeting also and the Board discussed the Coop Workshop with both Boards.
