Matt Drew gave a report on summer school, summer weights, and kids going to National SLC.

Wade Finley discussed NASB Policies, Federal program administrator, buildings and grounds, playground, storm damage update, and intercom system.

Marie Sweley made a motion to approve new and changes to existing NASB policies; 204.12, 508.17, 702.03, 702.03R1, R2, R3, R4, 902.02, and 902.04. Second by April Gross. Motion carried 5-0.

Marie Sweley made a motion to recommend that Matt Drew will be assigned as the Litchfield Public Schools Federal Program Administrator for the remainder of the 2022 calendar year. Second by Cole Lewandowski. Motion carried 5-0.
